2(i)	Comprehensive Development: For comprehensive development of border districts, BADP will have two components - first will be saturation of beneficiaries and ensuring creation of infrastructure in border districts through convergence of various Government Schemes, and second part will be Border Area Development Scheme(BADS) for convergence and filling up gaps to achieve desired levels of development. 4.2(a)	10% of the total allocated funds will be kept reserved under BADS (called BADS Reserve Fund) and will be utilized for incentives for better performing State/UTs.	Upto 05% of the total funds allocated annually under the programme will be utilized by MHA, Gol for Administrative expenditure related to BADP. It shall cover activities such as implementation of Project Management Unit (PMU) at National/ State/ District level and other establishment charges in MHA, Gol, organizing awareness programmes, functions such as Seemant Kshetra Vikasotsava, imparting Training, capacity building, conducting of Seminars, equipment and manpower for development of BADP Online Management System, Third Party Evaluation (TPE) of BADP, consultancy services, hiring of vehicle etc. Not less than 05% of the total funds allocated annually under the programme will be kept as reserve fund and will be utilized by MHA for rewarding better performing districts by providing them additional funds for key projects in border areas/ for sanctioning additional schemes based on assessment/ any important work/project which could not be taken up in the Annual Action Plan. Administrative expenditure relating to BADP and the total allocation under Reserve Fund shall not exceed 10% of the total annual allocation of BADP.
4.8	A baseline survey and spatial resource mapping must be carried out in border villages/ towns in order to identify the gaps in basic physical and social infrastructure. The State/UT Government will fill up these gaps through the developmental schemes of the Government, including BADS.	To assess the gaps in basic infrastructure, surveys conducted by other developmental ministries/ State Governments/ institutions of Government of India will be utilized. The Districts/ States/UTs shall be mandated by Ministry of Home Affairs to make use of such survey data while formulating Annual Action Plans under BADP.
5.3	A list of work/project, which can be taken up under Border Area Development Scheme (BADS) is at <b>Annexure-I</b> . Works/projects under BADS should focus on the benefit of the community. In this regard, the State/UT Government is required to furnish a certificate to Ministry of Home Affairs stating that all interests or other earnings against Grants-in-Aid to the State/UT Government or advances (other than re-imbursement) released to any institution under Border Area Development Scheme(BADS) has been deposited in the BADS Account maintained at the State/UT level immediately after annual finalization of the accounts and the amount has been deposited in the exclusive BADS account maintained at State/UT Level.	As per Rule 230(8) of GFR-2017, all interests accrued on deposits of BADP funds at any level shall be mandatorily remitted to the Consolidated Fund of India (CFI) immediately after finalization of accounts. In this regard, the State Government/UT Administration is required to furnish a certificate to Ministry of Home Affairs stating that all interests or other earnings against Grants-in-Aid to the State Government/UT Administration under Border Area Development Programme (BADP) has been deposited in the Consolidated Fund of India (CFI) immediately after annual finalization of the accounts.
