2. Allocation of fund is subject to adherence of the following:

a) These allocations are purely indicative in nature and this shall be utilized by the department only after verifying the actual requirement and observance of guidelines and all the financial rules, regulation, provision, prescribed in GFR, DFPR etc. & guidelines/circulars/ OM's/ directives missed by the CVC, MoF, MAH, Gol, Administrative Ministries of Gol & GoAP from time to time in this regard in letter & spirit without fail.

- b) These allocations cannot be diverted for any other purpose and also amongst the sanctioned schemes. The project shall be completed within the approved estimated cost and stipulated time frame. No revised estimate/ cost escalation shall be entertained.
- c) Commissioner /Secretary (Power) shall monitor the progress of works and ensure that payments are made after making necessary verifications at ground level. Further, the amount only as actually required should be used and the balance amount, if any, should be surrendered.
- d) Finance Department shall ensure that LOCs are issued only after ensuring that all codal formalities including proof of tenders have been observed and also proof of documents confirming the completed portion of the schemes/works are submitted.
- e) The expenditure shall be adjusted from Planning & Investment Department's ADA 2018-19 for which necessary fund provision has been earmarked as SIDF by the State Budget Division and shall be regularized at the time of RE.
- f) Department shall restrict the contingency charges of the project as per the latest instruction of FD in this regard.
