Representatives from MHA, DoNER, Niti Ayoug, Tawang and Longding districts did not attended the meeting due to preoccupation.

At the outset, Secretary (Planning) welcomed the members for attending the meeting and asked for their valuable suggestions and comments during the course of meeting. Secretary (Planning) also appraised all the members to maintain the instruction issued by Ministry of Home Affairs and State Government while approving the schemes of BADP proposals.

Detailed discussions on the agenda items were held and the following decisions emerged in the meeting :-

Agenda Item No.1	CHANGE OF FUNDING PATTERN OF BADP w.e.f 2016-17.
-------------------------	---

On the basis of the approval of the Union Cabinet on the recommendations of the sub-Group of Chief Ministers on rationalization of the Centrally Sponsored Schemes (CSSs) the BADP has been placed in the list of Core Centrally Sponsored Schemes (CSS) covering items of National Development Agenda.

1.1 Henceforth, funding of BADP would be shared by the States as 90 : 10 for 8 North Eastern States and 3 Himalayan States and for other states it would be 60 : 40. The new funding pattern will be applicable from 2016-17 and state have to provide their share as per the recommendation for the current year by funding some new projects equivalent to their share corresponding to the amount released by centre.

1.2 During 2016-17 the total allocation under BADP as was communicated by MHA is ₹103.00 Cr, out of which an amount of ₹ 96.4915 Cr (₹ 82.8651+ ₹ 3.3264 + ₹10.30) has already been released being 1st & 2nd installment and balance Rs. 6.5085 Cr is pending due to non submission of UC for 2014-15. Hence, to comply the directive of the MHA a State share to the tune of ₹ 9649.15 lakh (being the 10% of the total fund released so far by MHA during 2016-17) is now needed to be released by the State Government out of the total State share requirement of ₹ 0.30Cr during c.f.y.

1.3 As during 2016-17 the Annual Action Plan (AAP) for ₹ 103.00 Cr has already been submitted to the MHA prior issuing the directive of the fund sharing, it is now necessary to submit supplementary AAP for ₹ 1072.10 lakh (i.e the proportionate provision of State Share against fund released by Gol) for consideration of MHA. The release of fund to the districts against these proposals will depend on actual release of fund by State & Central Government.

Decision :

The modification in the pattern of funding under BADP was elaborately explained amongst the members and the SLSC has considered for submitting supplementary Annual Action Plan for ₹1072.10 lakh during 2016-17.

Agenda Item No.2	APPROVAL OF THE SUPPLEMENTARY ANNUAL ACTION PLAN TO BE SUBMITTED TO THE MINISTRY OF HOME AFFAIRS FOR THE YEAR 2016-17 AGAINST THE STATE SHARE PROVISION

2.1 It has been observed that the block level proposals received from the districts are very thinly spread whereby visible and tangible assets are not created except in few cases. Further, there is hardly any time now to collect proposals from the block / district levels for submission to the MHA.

2.2 Further, huge numbers of proposal were received from the districts being additional schemes and hence it may perhaps, be appropriate to select specific viable projects out of the additional schemes received so far for supplementary AAP.

2.3 During 2015-16 a scheme "Construction of FSB over Yansang River in between Singa and Shitroma for ₹ 10.00 lakh" pertaining to Singa Gelling Block could not be implemented due to non release of fund by MHA for late submission of UC against the fund released during 2013-14. This proposal needs to be included in the Supplementary AAP.

2.4 In this connection, HCM has announced in his Independence Day speech to develop Model School for ₹ 50.00 lakh per school per district. This may also be considered for the specific areas. School Education Department will submit details of the proposals for model school.

Decision :

The SLSC has decided to take up the following 10 nos of Model Schools @ ₹99.72 lakh in the border areas selected by the Education Department in consultation with concerned DCs. The model school proposal are to be covered with all the primary components after considering proper facilities like Internet connectivity, Laboratory, Libraries, Smart Class room, teachers room, play ground etc in border areas for uniform development amongst the model schools

Agenda Item No.3	CONSIDERATION OF ALTERNATIVE SCHEMES OF SKILL DEVELOPMENT.

3.1 During 2016-17 proposals for an amount of ₹ 5.15 Cr was kept for taking up of proposals for Skill Development and Training. Initially proposals were received from the concerned districts and after approval of the projects by the MHA to maintain uniformity amongst the border blocks, Skill Development Department was asked to prepare a comprehensive proposal for the border blocks. The proposal was received and placed for consideration of the SLSC for recommendation to MHA.

Decision :

To maintain the uniformity the SLSC has decided to recommend the comprehensive Annual Action Plan prepared by Department of Skill Development and Entrepreneurship for implementation during 2016-17 through the concerned Deputy Commissioners. Further, SLSC also emphasized to train the youths of the border villages in a professional manner to enabling for setting up of local entrepreneur in the border areas.

4.1 In the 24th Empowered Committee Meeting the Secretary (BM) has emphasis that an amount of Rs.50.00 Cr is available being the reserve fund for contingencies and State Governments was asked to submit additional proposals under BADP.

4.2 A huge number of additional proposals have already been received from concerned districts out of which selective proposals may be considered by the SLSC for recommendation to the MHA.

Decision :

The SLSC has decided to recommend following proposals @ ₹1.33 Cr per district for consideration under additional BADP projects during 2016-17 in respect of Arunachal Pradesh.

Agenda Item No.5 STATUS OF SUBMISSION OF UC .

5.1 According to the BADP guidelines, the 1st installment of 90% of the allocation of the State will be released to the State only after the receipt of UCs for the amount released in the previous years except the preceding year. If there is any short fall in furnishing the UCs for the amount released during the pervious year, except the preceding year, the same would be deducted at the time of release of the 1st installment. The 2nd installment of the remaining 10% of the allocation will be released to the State only after furnishing of UCs to the extent of not less than 50% of the amount during the preceding year.

According to the BADP guidelines the Annual Action Plan under BADP is to be finalized and submitted to the MHA in a time bound manner. The details of the time frame is mentioned below :

6.2 Accordingly, a decision may be taken by the SLSC to instruct concerned DCs for preparation of Annual Action Plan under BADP for **2017-18** on the basis of current year allocation + 10% state share provision with a supplementary AAP (with priority) for 20% of the current year allocation and submit the same according to the time frame mentioned in the BADP guidelines.

6.3 The final proposals will be selected on the basis of the allocation receipt by MHA for 2017-18 by considering the priority mentioned against the respective proposals recommended by the DLCs.

6.4 In the 24th Meeting of the Empowered Committee on BADP Secretary (BM) impressed upon that BADP funds should go to the areas as nearer to the border as possible. State Government should not recommend any scheme which is beyond 0-10 km from the border.

Decision:

The SLSC has instructed to the concerned Deputy Commissioners to prepare the Annual Action Plan for 2017-18 after observing necessary instructions issued by MHA in this regard and submit the same in a time bound manner enabling to recommend the same to MHA within the specified timeline. Further SLSC also directed that the proposals recommended by the Border Guarding Forces (BGFs) should be prepare as per latest APSR.

Agenda Item No.7	Consultation with MPs / MLAs / PRIs

7.1 According to the BADP guidelines DLC shall have consultation with concerned MPs / MLAs / PRIs / Development Agencies etc while preparation of AAP of the district level to know the felt-needs of the people and will give due consideration to their proposals. The DLCs shall take final decision keeping in view the people's priorities and its own assessment for bridging the gaps in public infrastructure and services and selection of works within the overall sectoral priorities.

7.2 DLCs should furnish a certificate along with the AAP stating that DLCs have consulted the local MPs / MLAs / PRIs etc while selecting the schemes of BADP at the district level based on which necessary certificate is to be furnished by the Nodal Department to MHA.

7.3 In this connection a number of complain was received from various corners regarding non consultation with concerned MLA / PRI etc. and recently MHA has forwarded a complain regarding non consultation in respect of West Siang, Kurung Kumey, Changlang and Tirap Districts.

Decision:- The SLSC has directed the concerned Deputy Commissioners to strictly follow the instruction issued by the MHA regarding consultation with MPs/MLAs/PRIs prior selecting / proposing projects of BADP at the district level and should submit necessary consultation certificates separately for while submitting AAP to Nodal Department for onward submission to MHA.

Agenda Item No.8	Preparation of Perspective Plan for next Five Years.

In the 24th Meeting of the Empowered Committee it was decided that the state Governments should find out the basic needs of the Border Area people and concerned DCs should prepare a saturation plan of each village within 0-10 km from International Border. Based on the saturation plan a perspective plan for the next five years is to be prepared for submission to MHA for projection the requirement of funds under BADP to fulfill the expectation of people in Border Areas.

8.2 The SLSC may like to decide over preparation of perspective plan of the border villages located within 0-10 km of the International Border.

Decision:-

SLSC directed to the concerned Deputy Commissioners to prepare Perspective Plan for the next Five years as decided in the 24th Meeting of the Empowered Committee for assessing the requirement of funds under BADP in the next five years.

A continuous monitoring system should be developed at the district level for implementation of BADP schemes. The schemes should also be monitored by the District Level Monitoring Committee. The monitoring report should be submitted along with the QPRs and UCs.

9.1 It has been observed that QPRs are submitted after a long gap of quarter ending whereas according to the guidelines the QPRs should be submitted to MHA by 15th of every quarter ending. Accordingly, it is needed that QPRs from the district should be submitted to the Planning Department by 10th after every quarter.

9.2 All the BADP projects should be implemented w.e.f. 2016-17 along with GPS coordinates to facilitate monitoring of the projects by Gol.

Decision:-

The SLSC has instructed to the concerned Deputy Commissioners to strictly comply necessary instruction issued by the MHA regarding monitoring of BADP proposals at the district level and submit necessary monitoring report along with QPRs within the specific timeline for submission to MHA. The QPRs should be enclosed along with photographs indicating GIS location, year and amount embedded over the photographs. The Completion certificate of BADP project and photographs should be accompanied with the UC.


