



Dear Shri Kiren Rijiju Ji.

You might be aware that different Central Government Ministries have made guidelines for inauguration of various development projects under their purview to ensure effective participation of local Members of Parliament. I write today to ask for a similar procedure to be followed for projects instituted under the Border Area Development Program (BADP). Currently, in the absence of any guidelines, state governments often follow their own protocols for such functions leading to much confusion.

I urge your ministry to issue suitable directions so that inaugurations, foundation stone laying of all projects under the BADP are carried out by the local MPs, with the function presided over by other dignitaries as per extant protocols. This may be communicated to the local District Collectors at the earliest to ensure proper compliance. *(East Champaran district)*

I am sure that you will address this issue as soon as possible, so that people's representatives are given the respect and recognition that they rightfully deserve.
