- 3. The details of block / schemes against which funds are now transferred is given at Annexure-I.
- 4. While releasing fund vide letter No. PD/ BADP-12/2019-20/3476 dtd 04/09/2020 an excess amount of Rs.2.50 lakh has been inadvertently transferred to Upper Subansiri District in respect of project "Capacity Building Training Programme on weaving of local dress, like Gale, Galuk, etc. in Siyum block". Accordingly, an amount of Rs. 2.50 lakh is hereby adjusted from the previous release vide letter No. PD/BADP-12/2019-20/3476 dtd 04/09/2020 for implementation of the projects mentioned in the Annexure-I enclosed herewith as mentioned above.
- 5. While releasing fund vide letter No. PD/BADP-12/2019-20/2661 dtd 16/03/2020 an amount of Rs.184.50 lakh has been inadvertently transferred in respect of Dibang Valley District instead of Rs. 187.00 lakh. Accordingly, the shortfall amount of Rs.2.50 lakh is hereby adjusted and now transfer for implementation of the project "Skill Development and Training on organic farming in Agriculture Sector (No. of trainees=30, trade=T)" for which shortfall in previous released vide letter No. PD/BADP-12/2019-20/3476 dtd 04/09/2020 happened.
- 6. The concerned Deputy Commissioners shall further release the fund to the implementing agencies through PFMS only after ensuring compliance of following terms and conditions:
 - i. All codal formalities, financial rules and regulations and all conditions laid down in GFR, DFRP, circulars, directions & guidelines etc issued by the Govt. of India, MHA, Ministry of Gol, CVC and Govt. of Arunachal Pradesh from time to time should be strictly adhered to in letter and spirit without fail. Any violation of above shall squarely be the responsibility of the District Administration and implementing department. Subsequent release will depend upon utilization of the previous releases through PFMS platform only after obtaining expenditure sanction from the competent authority.

- The execution of works / schemes / projects and procurement of items / materials, furniture, etc should be done strictly as per the provision of GFR, DFPR, financial Rules and regulations and the guidelines and directives issued by the Govt. of India, Ministry of Finance, Gol / Administrative of Gol, CVC and Govt, of Arunachal Pradesh in this regard from time to time. The process of tendering and competitive bidding should be mandatorily followed and complied with as envisaged in the GFR, DFPR, CPWD Manual.
- iii. The Contractors / Suppliers / Vendors payment must be made through Expenditure, Advance & Transfer (EAT) Module and the beneficiary payment through DBT module. The department shall deposit the deductions made to the respective head of accounts through RTGS / Cheque / DD and intimate the same to office concerned for making necessary entries and updating the record. Asset Register and Album containing photographs in the three phases as indicated in the guidelines (before, during & after implementation / completion) for all schemes sanctioned under BADP maintained properly for record and future uploading in the portal. The date, longitude & latitude should clearly be shown in the photographs.
- iv. Further, regular monitoring of the schemes by the District Level Committee as mentioned in the guidelines must be carried out regularly and report of the same should invariably be submitted to Planning Department from time to time. The District Level Committee shall be solely responsible for proper implementation of schemes at the district level.
- ٧. Geo tagging of all projects is compulsory. Change in location and scope of work of any project is not permissible.
- Utilization Certificates and Expenditure Statement must be submitted to Planning vi. Department immediately for further necessary action at this end.
- vii. No revised estimates/sanction will be entertained and no expenditure outside the scope of the approved scheme is permissible.
- viii. Necessary instruction issued vide No. PD/BADP-04/2018-19(Part)/1082 dtd 13/02/2019 should be adhered to while implementation of schemes at the district level.
- 5. This issue with the approval of the competent authority.
