under Major Head "2575"-Other Special Area Prgramme - Sub Major Head - 60 - Others - Minor Head - 800 - Other Expenditure - Sub Head - 01 - Border Area Development Programme - Detailed Head - (21-Deputy Commissioners) - Object Head - 50 - Other Charges - Plan - Demand No.- 06 respectively.

- As the fund is spillover from 2014-15, immediate utilization is urgently required for submission of UC to MHA for getting proportionate fund deducted by MHA during 2016-17. Hence, it must be ensured that the schemes should be completed immediately and utilization certificate should be submitted immediately against the total fund released in this regard.
- While executing the schemes following points should be taken into account :-
 - The approved schemes for Skill Development and Training should be implemented in accordance with the guidelines, instruction and common norms issued by the line ministries in this regard, it time to time.
 - Necessary administrative / technical and expenditure sanction of the approved scheme should be obtained from the competent authority before execution of the schemes. No change / deviation of the approved scheme is allowed.
 - iii. Fund should be released for 100% completion of the project. No deviation in the approved scheme / estimates can be made.
 - iv. The concerned Deputy Commissioner shall accord administrative approval and expenditure sanction within their financial power i.e. Rs.10.00 lakhs in each case.
 - Utilization Certificates and Expenditure Statement must be submitted to Planning Department immediately for getting proportionate fund deducted by MHA for 2016-17.
 - vi. Asset Register and Album containing photographs in the three phases as indicated in the guidelines (before, during & after implementation / completion) for all schemes sanctioned under BADP should be taken up properly and maintained for record and future uploading in the software. The date, longitude & latitude should clearly be shown in the photographs.
 - vii. Necessary instruction issued by FD and vide No.PD/BADP-1/2015-16 dtd 20/06/2016 should be adhered to while implementation of schemes at the district level.
