Implementation of schemes/projects is subject to adherence of following terms and

- (i) This allocation is purely indicative in nature and this shall be utilized by the departments only after verifying the actual requirement and observance of guidelines of State Infrastructure Development Fund (SIDF) and other codal formalities.
- (ii) All works will be awarded on the basis of a transparent tender and all GFR/CVC guidelines should be followed in such awards.
- (iii) The department shall incur expenditure only after necessary budgeting in consultation with the Finance, Planning & Investment Department of Budget Division which will be regularised at the time of finalization of RE 2017-18.
- (iv) All schemes should be completed as per time line so that there is no cost or time over run.
- (v) Fund should be utilized for the purpose for which it is allocated and cannot be diverted for any other purpose.
- (vi) Concerned Commissioners/Secretaries will monitor and review the progress of implementation of various schemes/ projects at regular intervals and shall ensure timely submission of quarterly progress report, utilization certificate, photographs and completion certificate etc. as applicable only after necessary review/ verification at their level.
- (vii) Violation of above instruction/guidelines will be the sole responsibility of the officers concerned. Further, the amount only as actually required should be used and the balance amount if any, should be surrendered.
